### FARMERS MARKET COMMITTEE REPORT

#### **Good News**

April gross revenue was \$7714.00 compared to April 2019 of \$5729.62. The market was closed in April 2020.

Vendor Count 55+ each week. We continue to receive inquiries and applications. The committee is reviewing vendor mix to ensure we are perceived as a true Farmers Market. We have relaxed Market rules to meet the current CDC guidelines regarding masks and social isolation. Customers and vendors appreciated this change.

We purchased 6 bistro sets to encourage customers to stay at the market, eat the delicious food, listen to music, and hopefully purchase more products from our vendors.

#### **Bad News**

We received a letter of resignation from our manager, Laura Bennett. She will be moving to Missouri in June. We are searching for a new manager. It will be difficult to replace Laura. Not only is she organized and efficient and has streamlined operation procedures, but she is also loved by the vendors and committee members.

One of our young helpers, Charlie is leaving us in June. We are searching for a replacement. In April, the trailer that was stored at U-Haul storage, a locked storage facility, was broken into. Nothing of value was taken but the hasp to close the trailer was broken and had to be replaced. Jimmy Bissig completed the repairs.

The following week, the shed that is located behind Randall's, was broken into and \$160 dollar gorilla wagon was stolen. The lock and door were pried open, leaving the shed not able to be locked. The door was left open until it was discovered, and the driving rains soaked the inside of the shed. Police reports were made for the two events.

Kelly and Aaron found a new storage facility that is more secure and large enough that we will not need the shed in the future. The cost will be double what we are currently paying but the committee agreed it is the right thing to do.

We believe we have a buyer for the shed.

A SWOT Analysis, which was suggested by Pat Goodpastor, will be conducted Saturday, May 15 and led by Neil Gaynor. We will be able to report the action plan developed by this exercise at the Meeting, Monday, May 17.





### PARKS & RECEATION ADVISORY COUNCIL REPRESENTATIVE

I reached out to Dr. Chris Nunes this week. He and his team are super busy and getting lots done. Here are the highlights:

- Bridge Renovation Nature Trail Bridge Bridge Near Grogan's Mill Shopping
   <u>Center</u>: The Grogan's Mill bridge renovation bid is underway. This is for the nature bridge off of Glen Loch Drive that parallels the golf course. This is the largest project that they currently have underway in Grogan's Mill. They anticipate having this reviewed by the Township Board at their May 26 meeting and if approved construction should commence a few weeks thereafter.
- Bear Branch Park: A new inclusive playground is being considered at Bear Branch Park. It would be offer equipment and experiences for all types of children (e.g., blind, deaf, autistic and mobility impaired) and is designed with easy accessibility specifically in mind. The estimated price will be ~\$600K. The targeted completion date is October 2021. Board approved and moving forward with two (2) vendors to secure designs and prices. They will be returning to the Township Board with prices and designs in July 2021.
- <u>Park Design Renovation Plans</u>: There is a plan to renovate and upgrade Falcon Wing Park in Indian Springs. The upgrade would be similar to the one done to Sawmill Park in

2012. The Township Board will be presented with proposals for designs at their May 26<sup>th</sup> meeting.

• <u>Summer Opening</u>: P&R has a summer goal of opening all 14 pools and all camp programs within The Woodlands. It is desired to also fully staff all summer positions (e.g., Life Guards, Camp Counselors, etc.). Last season, due to the COVID Pandemic, only 7 of 14 pools were open unfortunately. Available summer jobs will be listed on The Woodlands Township website, so encourage local kids to apply. This is going well. To date, P&R successfully opened 9 pools for the pre-season (including Sawmill) and will have all 14 pools open during regular season which starts in June. Friendly reminder, they have the pools open and are encouraging people to go to the pools and purchase their pool pass. To this end, please tell your constituents to buy pool passes.

#### **MUD REPORT**

### Major Water Line Cut by Contractor in Grogan's Mill

An Entergy contractor cut a 16" SJRA water line, near Grogan's Mill and South Millbend, on Thursday, May 6 at about 4:00 PM. Some residences in the Timberwild area were without water for approximately 5 hours. A temporary patch was in place that night, with a permanent patch installed on Friday night. If you have a service interuption check the Woodlands Water Agency sites on Twitter and Facebook for information about the outage.

## **Groundwater Management in Montgomery County**

Groundwater Management Area-14 has oversight of groundwater pumping for several Groundwater Conservation Districts (GCD) in the southeast Texas, including Lone Star (LSGCD) here in Montgomery County. Every five years proposed Desired Future Conditions (DFCs) for groundwater are published for review and public comment prior to final adoption. The members of GMA-14 agreed to consider propsed DFCs in the current planning cycle, which state:

In each county in GMA 14, no less than 70 percent median available drawdown remaining in 2080 and no more than an average of 1.0 additional foot of subsidence between 2009 and 2080.

LSGCD announced that a ninety-day public comment period on the proposed DFCs ending on July 19, 2021. Individuals are invited to submit comments in writing to the following email address – <a href="mailto:info@lonestargcd.org">info@lonestargcd.org</a> with DFC Comments in the subject line. LSGCD will also be holding a public hearing during the 90-day comment period. If you wish to speak in person, you will need to register for the hearing. The hearing for public comment is now planned sometime in the time frame of June 7-9, 2021.

LSGCD is also soliciting comments on the proposed Phase II of their subsidence study, which are open until 5 PM on May 28, 2021. Send your comments to <u>info@lonestargcd.org</u> with Subsidence Phase II Study in the subject line. The scope of the study will be approved at the June 8, 2021 board meeting.

## Resolution on Groundwater Pumping and Subsidence

Groundwater pumping can lead to compaction of clays in the aquifers from which water is pumped. In turn, the land surface will sink. This is happening here in The Woodlands. Surface water made available in 2015 reduced groundwater pumping and stabilized subsidence for a time, but increased pumping rates has caused subsidence to start again. On May 12, at their regular monthly meeting, The Woodlands Water Agency (WWA) Board of Trustees voted unanimously to approve a resolution requesting LSGCD to permit only sustainable levels of groundwater pumping and to monitor subsidence. The same resolution will be on the monthly agendas for each MUD comprising WWA during the week of May 17.

## **Funding Approved for Bear Branch Flood Mitigation Project**

The Texas Water Development Board approved financial assistance for \$11,300,000 for a flood mitigation project on Bear Branch near Research Forest Drive and Gosling Road. The primary recipient of this assistance is MUD 67. The project comprises channel improvements, construction of two detention ponds, and hydrologic and hydraulic studies. This project will mitigate flooding along Research Forest west of Gosling, and in neighboring residential areas. Bear Branch is a tributary of Panther Branch which runs through the west and south of Grogan's Mill.

## The Yoars CORS Station is Up and Running

The Yoars CORS GPS station located on South Tranquil Path in Grogan's Mill is now recording data. To review the data go to the link for an interactive map sponsored by the Houston Galveston Subsidence District (HGSD). You will need to zoom into The Woodlands and look for a small circle labeled YORS near Spring Creek. Click on the symbol to see and download the data.

GMVA partnered with Houston-Galveston Subsidence District, San Jacinto River Authority, and The Woodlands MUDs in funding the installation of this elevation measuring device. CORS is an acronym for Continuously Operating Reference Station. These instruments use GPS signals to record minute changes in land elevation and are critical to documenting subsidence. Subsidence in our area, due to excessive groundwater pumping, may increase the risk of flooding of homes and businesses. Kudos to John Yoars for his efforts to have this technology brought to Grogan's Mill.
